### **Preface**

ICOMOS INTERNATIONAL CONSERVATION CENTER--XI' AN (hereinafter as IICC-X) is an international organization which is devote to the cultural heritage protection and conservation, management, presentation; the arrangement and coordination of international and domestic academic training, provide assistance and consultancy for domestic conservation and planning projects as well as communication and legal advisory.

On 7th November 2009, at the first meeting of the Coordination Committee on the Serial Transnational Nomination for World Heritage of the Silk Roads, IICC-X had taken the responsibility as the secretariat of the Coordinating Committee on Serial Transnational Nomination for World Heritage of the Silk Roads (founded by 12 respective countries related to the Silk Roads: Afghanistan, China, India, Iran, Japan, Kazakhstan, Korea, Kyrgyzstan, Nepal, Tajikistan, Turkmenistan, Uzbekistan). On 27th December 2011, a working group was set up under the Steering Committee of "Silk Roads: Initial Section of the Silk Roads, the Routes Network of Tian-shan Corridor" (Kazakhstan, Kyrgyzstan and China) and IICC-X was designated the Secretariat and Information Center of the working group. IICC-X focused on the Silk Roads Serial Transnational Nomination, and began to collect nomination dossiers, management and monitoring documents and research materials of all sections and sites along the Silk Roads, IICC-X has organized transnational investigations along the Silk Roads, provided technical assistance to cultural heritage protection and conservation programs, promoted cultural exchanges and training programs of heritage conservation, received domestic and foreign praise.

In the year 2012, with the guidance and support from ICOMOS, ICOMOS China, China Administration of Cultural Heritage (S.A.C.H), Shaanxi Provincial Administration of Cultural Heritage and Xi' an Municipal Bureau of Cultural Heritage, IICC-X solidarized with all levels of units and organizations, advocated heritage conservation principles and experiences from ICOMOS and S.A.C.H, played the role of international platform, concentrated on the Silk Roads Nomi-nation, established the Silk Roads Archive and Information Management System (AIMS), extended cultural heritage protection management and technical personnel training, launched technical research and project cooperation on cultural relic protection, provided and expanded cultural heritage consultation, promoted domestic and international exchange on heritage conservation, successfully accomplished the tasks delegated from international and domestic units and organizations at all levels.

2009年11月7日,"丝绸之路跨国申遗协调委员会第一次会议"上确立IICC-X为丝绸之路跨国系列申遗协调委 员会(中亚五国、日本、韩国、印度、阿富汗、尼泊尔、伊朗)秘书处 在2011年12月27日"丝绸之路跨国系列申遗协商会" 签署的备忘录中, IICC-X 又被确立为"丝绸之路: 起始段和天山廊道的路网"申遗协调委员会工作组秘书处(中国、哈 萨克斯坦、吉尔吉斯斯坦三国),中心围绕丝绸之路跨国系列申报世界遗产,积极开展资料收集整理、组织丝路跨国考察、 提供文物保护技术援助、推动国际交流与合作等方面的工作,获得国内外的一致好评。

2012 年, IICC-X 在国际古迹遗址理事会(以下简称 ICOMOS)、国家文物局、中国古迹遗址保护协会、陕西省文物 局、西安市文物局的指导与帮助下,积极团结各级文化遗产保护力量,宣扬传播 ICOMOS、国家文物局关于文化遗产保 护的理念、经验,积极主动地发挥国际平台作用,围绕丝绸之路申遗这个核心工作积极谋划,着重在构建信息交流与档案 管理平台、拓展文物保护管理与技术人员培训,开展文物保护技术研究与项目合作、提供文化遗产保护业务咨询等方面 拓展业务,努力推动国际、国内文化遗产保护领域的交流与合作。圆满完成了国际、国内及各级单位委托的工作任务。

Strengthen the exchange and communication with ICOMOS

IICC-X proceeds to strengthen the communication with ICOMOS, by periodically report to ICOMOS Secretariat, and distributing the Newsletter on Serial Transnational Nomination for World Heritage of Silk Roads regularly.

• Promoting international interchange and influence

On 18th Oct 2012, Ms. Marie Louise Anker, the president of ICOMOS Norway visited IICC-X, learned IICC-X's current work and discussed the stakeholders' investigation and survey in Chang' an Sites of Han Dynasty. On 5th Nov 2012, Mr. Peter Cox, the president of ICOMOS Ireland visited IICC-X, learned the present work of Silk Roads Nomination, introduced the general statues and on-going projects of ICOMOS Ireland, proposed the exchanging and training programs between Chinese and Irish staffs.

In the year2012, IICC-X welcomed experts in Cultural Heritage education and research field. Archaeologist and pioneer of post-processualist theory in archaeology, Prof. Ian Hodder from Stanford University came and lectured in Xi' an. Together with him, Prof. Lynn Meskell shared her thoughts about the new challenges and opportunities emerged in the 34th Session of World Heritage Committee in 2011. Professor Tim Williams from University College London, discussed with IICC-X staff about the ICOMOS Silk Roads Thematic Study and the AIMS system. Also, Prof. Gerard Corsane, from Newcastle University, UK, visited IICC-X.

On 18th Aug 2012, Ms. Ona Vileikis, researcher from Raymond Lemaire International Centre for Conservation (Katholieke University Leuven), director of project "Cultural Heritage Resource Information System (CHRIS)" visited IICC-X, discussed the collaboration between two systems, affirmed that the information in CHRIS can be linked and shared in AIMS.

#### • 促进国际交流,提升国际影响

#### Stress on publicity

In the year 2012, focused on introducing the establishment and development of IICC-X, to both public and government, propaganda was reinforced by two methods: Bulletin Board in IICC-X and work publicity in Xi' an municipal government.

There are 3 parts on the Bulletin Board: Firstly, general information of ICOMOS, UNESCO, WHC: Secondly, Briefs of IICC-X and the work in 2012; Thirdly, knowledge about cultural heritage, the Silk Roads and Silk Roads Nomination.

#### • 注重中心的宣传工作

## Establishing Silk Roads Information Platform 搭建丝绸之路信息平台

• Launching the Silk Roads Archive and Information Management System (AIMS)

Based on the work deploy and financial support of the Silk Roads Nomination by S.A.C.H in early 2012, IICC-X was entrusted to establish the Silk Roads Archive and Information Management System (AIMS for short). The system is indexed by IICC-X website, comprised of 4 modules with the main function of Archive and Information Management. The system is launched as World Heritage Nomination information interchange and archive management platform. Post-nomination tasks such as monitoring and tourism are also being developed.

The interface of heritage sites in the system has three parts for registered users. General information of the Silk Roads Nomination is on the upward side, which includes introduction, events, information etc.: Public information section is on the right side, includes brief information of heritage and tourism information; professional archive and information management platform is on the left side with a speed-dial formation, which illustrates management information, protection and exhibition projects, archaeology and other relevant documentation of heritage conservation. All the above components provide useful fundamental data for the construction of Silk Roads archive information centre.

Archive and information modules of the AIMS have been successfully launched; primary on-line functions such as browse and download have been initially achieved.

登录后的遗产点界面分为三个部分,页面上方是丝绸之路申报世界遗产总体信息介绍,包括丝路介 绍、丝路申遗大事记、丝路资讯等;页面右侧为公众信息栏,包括遗产简介、旅游信息等;页面左侧是针对 各遗产点设计专业档案信息管理平台,以九宫格形式排列,展示遗产点的管理信息、保护展示工程,考古及 相关研究资料。为丝绸之路档案信息建设提供有益的基础资料。

• Published the Newsletter on Serial Transnational Nomination for World Heritage of the Silk Roads.

In May 2011, after the coordinating meeting in Turkmenistan, authorized by the SACH, as the secretariat and information center of Coordinating Committee on Serial Transnational Nomination for World Heritage of the Silk Roads, IICC-X published the Newsletter on Serial Transnational Nomination for World Heritage of the Silk Roads, to improve the information exchange and communication of the Coordinating Committee, and to assist the Silk Roads Serial Nomination by schedule.

The trilingual (in English, Russian and Chinese) quarterly Newsletter is focused on the Silk Roads Serial Transnational Nomination. Its mission includes reporting significant progresses of the Serial Transnational Nomination of the Silk Roads, and the latest outcomes of coordinating meetings; research projects and outcomes which are related to the Silk Roads; introducing progresses achieved regarding conservation, management and project collaborations of nomination sites; sharing and communicating information of Silk Roads respective countries; briefing of work of IICC-X.


IICC-X has so far published 4 issues of Newsletter in both physical and digital version. The Newsletter is posted to the UNESCO WHC, ICOMOS, authorities, institutions and organizations concerned in the Silk Roads Nomination.

2011 年五月土库曼斯坦协调会议后,为保证申遗工作的不断推进,以及各国间信息交流的畅通和满足 国际社会对文化遗产领域最新发展信息的需求,IICC-X 作为丝绸之路跨国申遗信息中心以及丝绸之路跨国 申遗协调委员会秘书处,受中国国家文物局委托,制作丝绸之路跨国系列申遗简报,面向丝绸之路跨国申遗 所涉及各国、各组织、各地方和各遗产点发布,配合网络以及多媒体手段使各国各申遗点之间信息能够有效 传播,辅助跨国申遗计划如期顺利进行。

简报以中英俄三语,图文并茂的形式宣传丝绸之路申遗,遗产保护等领域相关会议的新精神,相关工 作的最新发展以及相关领域的最新科研成果;并为相关各国提供平等公开的信息发布平台,供各国宣传交 流使用。

简报正刊以 A4 大小,季刊形式发布,每三个月编辑发行一期,全年发行四期。每期同时提供纸质和 电子版。面向丝路申遗相关国家、联合国教科文组织及国际古迹遗址理事会等丝路申遗相关国际组织,丝 路申遗各遗产点的管理、保护和监测机构及国际研究专家等,《丝绸之路跨国系列申遗简报》已成功出版 并发布了四期。

Co-organizing/participating International Conferences and Workshops relevant to the Serial Transnational Nomination for World Heritage of the Silk Roads 承办、参加丝绸之路申报世界遗产相关国际会议

- Organized International Conferences and Workshops
- International Workshop on Cultural Routes Monitoring and Management

On 21st-23th April 2012, IICC-X organized "the international workshop on cultural routes monitoring and management" in Xi' an. This workshop was launched by SACH, co-organized by Shaanxi Provincial Administration of Cultural Heritage, Xi' an Municipal Bureau of Cultural Heritage and ICOMOS/China, organized by IICC-X. ICOMOS Experts from the U.S, Korea, Belgium, U.K and Spain, along with Chinese experts of cultural heritage conservation, representatives and officials from Silk Roads Nomination related regional administrations of cultural heritage, participated in the workshop.

Mr. Li Xiaojie, Deputy Minister of PRC Ministry of Culture, Director-General of SACH, interviewed the delegates during the workshop and inspected Chang'an City of Han Dynasty, Daming Palace of Tang Dynasty Chang' an City which are in the tentative list of Serial Transnational Nomination for World Heritage of the Silk Roads. He indicated that the Silk Road has great significance and influence, SACH gives profound attention to the conservation management and nomination. ICOMOS has greatly supported the Cultural Heritage conservation in China, SACH would like to enhance the communication and cooperation with ICOMOS to push forward Heritage conservation works such as the Silk Roads.

Mr. Tong Mingkang, Deputy Director-General of SACH, addressed keynote speech in the workshop. His topic was "The Protection and Management of Cultural Routes—Take the Silk Roads as An Example". He introduced the research, archaeological excavations, conservation, restoration, legislation and environment management work which have been done for the management and nomination of the Silk Roads by all levels of Chinese governments and Cultural Heritage Administrations. In the speech, Mr. Tong focused on the explorations taken to enhance the monitoring and management of large scale Culture Routes like the Silk Roads, he wishes that through international communication and cooperation, we can together push forward the conservation of Cultural Routes, especially the Silk Roads. Also, He introduced IICC-X's work as the Secretariat and Information Centre of the Coordinating Committee on Serial Transnational Nomination for World Heritage of the Silk Roads, and wished that IICC-X could strengthen its connection with international organizations to better serve the Nomination.

President of ICOMOS, Mr. Gustavo Araoz, gave his presentation "Adopting monitoring techniques to track integrity and authenticity in the attributes where values reside", he analyzed meanings of monitoring techniques to the large scale cultural routes such as the Silk Roads and objectives of management and monitoring. His presentation also provided rich examples and case studies to explain the relation between cultural value and requirements for heritage monitoring. In the end, Mr. Araoz spoke highly of the efforts that Chinese government and SACH have made in heritage conservation to protect from the impact of economic development. He also believes that China will play an important role in the field of international Heritage Conservation.

Vice President of ICOMOS, Director-General of IICC-X, Mr. Guo Zhan gave his speech on "The identification, combination, approach, phase-making and expectations for transnational world heritage nomination seen from the Silk Road nomination". He analyzed the world heritage values and combinations of the Silk Road, the approach and practice in the nomination; the consistency, uniformity and intrinsic relations as an organic whole of the Silk Road nomination; and summarized the Silk Road common features and suitable criteria for the nomination. Mr. Guo shared a lot of experiences and examples for large scale cultural route nominations, such as the Silk Roads.

Experts such as Ms. Rii Hae Un, from ICOMOS Executive Committee, ICOMOS Korea, Ms. Bénédicte Selfslagh, former ICOMOS Secretary General, Mr. Tim Williams, Expert on ICOMOS Thematic Study of the Silk Roads, Ms. Alicia Leonor Cahn Behrend, Expert of International Scientific Committee on Cultural Route, Ms.Chen Tongbin, Director of the Institute of Architectural History under China Architecture Design and Research Group, Mr. Wang Xijing, Deputy director of Xi'an Qujiang Daming Palace Heritage Site Area Preservation and Development Office, reviewed the concept of Cultural Routes and its specifics, the technics and strategy of Serial Nominations such as the Silk Roads, and also the monitoring of Cultural Routes as well as Cultural Heritage; and shared experiences on management and monitoring of international Cultural Routes; reached a common ground on complexity, longevity and flexibility of Cultural Routes' conservation. Valuable suggestions on the conservation and management of the Silk Roads heritages and sites were propounded during the workshop.

### • 文化线路监测管理国际研讨会

2012年4月22日至23日,文化线路监测管理国际研讨会在陕西省西安市举行。此次会议由国家文物 局主办,陕西省文物局、西安市文物局和中国古迹遗址保护协会协办,IICC-X承办。来自美国、韩国、比利时、 英国和西班牙等国 ICOMOS 专家,中国文化遗产保护领域的专家学者、丝绸之路中国段沿线省、自治区文物 主管部门的相关负责同志参加了会议。

文化部副部长、国家文物局局长励小捷会见了出席会议的中外专家代表,并和与会专家现场考察了汉长 安城遗址、唐大明宫遗址等丝绸之路遗产点。励小捷表示,丝绸之路意义重大,影响深远,国家文物局高度重 视丝绸之路遗产的保护、管理以及申报世界遗产工作,并为此付出了不懈努力。ICOMOS 长期以来对中国文 化遗产保护给予了巨大的帮助和支持,国家文物局希望进一步加强与 ICOMOS 的交流与合作,共同推进丝 绸之路等文化遗产保护工作。

### Promoting cultural exchanges and training programs of heritage conservation 促进文化遗产保护交流培训

• UNESCO Programme Specialist, Professor Roland LIN Chih-hung's lecture

October 31, 2012, Professor Roland LIN Chih-hung, UNESCO Programme Specialist was invited to give lecture entitled "World Heritage, Historic City and Sustainable Development" at the Northwest University. Students from School of Cultural Heritage and staffs of IICC-X attended the lecture.

In the lecture, Professor LIN explained the Convention Concerning the Protection of the World Cultural and Natural Heritage, Convention for the Safeguarding of the Intangible Cultural Heritage, and Convention on the Protection and Promotion of the Diversity of Cultural Expressions in detail, and introduced the importance of Conservation of World Heritage, Sustainable Development of Historic Cities. Questions and answers are frequently exchanged after the lecture.

The purpose of this lecture is to promote the protection of tangible and intangible cultural heritage, to popularize the knowledge of international laws system and cultural diversity, and to provide a platform for domestic students where they can contact with international cultural heritage conservation concepts.

#### • Professor Li Jianchao's lecture

On November 2nd, 2012, IICC-X invited professor Li Jianchao, expert of Silk Roads Study and professor of Northwest University, to give a lecture entitled "Han and Tang Dynasty' s Chang' an city and the Silk Roads" at Xi' an museum. Staffs from the museum, IICC-X, and Xi' an Cultural Heritage Archaeological Protection & Research Institute, together with students and tourist, enjoyed the lecture.

The purpose of the lecture is to help the public to understand the history, scale and concept of the ancient Chang' an city as well as the Silk Roads; the formation and the development of Silk Roads from the aspect of historical geography, and the importance of protection of the Silk Road Heritages.

According to the historical bibliography and his personal on-spot experiences, professor Li introduced the original geographic surroundings of Chang'an city and the development of the Silk Roads.

- Enhance the exchange with domestic cultural heritage organizations
- 1) IICC-X participated in the works concerning the compiling of the nomination dossier of the Silk Roads. In September 2012, IICC-X staff worked with the Institute of Architectural History under China Architecture Design and Research Group, to assist the translation of nomination dossier, Chapter 3 "Justification for Inscription" and Chapter 4"State of Conservation and Factors Affecting the Property".
- 2) IICC-X assigned staff to work in the Shaanxi Provincial Nomination Office to promote the Silk Roads Nomination in Shaanxi province. Under the arrangement of the State and Provincial administrations, the office is in charge of routine works, collecting datum and organize meetings for the nomination, etc.
- 加强与国内文化遗产保护机构的人员交流
- 1) 积极参与丝绸之路跨国系列申报世界遗产的申遗文本编制的相关工作。2012 年 9 月 IICC-X 派员参加了 中国建筑设计研究院历史研究所编制申遗文本第三章"列入理由"、第四章"遗产保护情况和影响因素"部 分资料的翻译工作。
- 2) 协助推动陕西省申遗工作, IICC-X 派员加入省申遗办公室。参与省丝路申遗日常管理工作, 收集整理丝路 申遗相关资料,组织申遗工作会议的召开,按照国家和省上的统一安排部署和工作计划,落实工作任务。



Entrusted by the Preservation and Conservation Institute of Fenghao Sites, protection scheme of Fengxi Chariot Pit was accomplished by IICC-X, based on filed survey and data collection. The first phase of the on-spot-preservation has been implemented from August to October 2012, including dust removal and biological control; rinsing, derusting, restoration, corrosion inhibition and seal-protection of the bronze relics; rinsing and reinforcement of dermal bone relics. Based on the test result of the Chariot Pit Sites, the earthen-change factors and biological pest condition will be analyzed for the conservation programme during the second phase.

受西安市丰镐遗址保管所委托,IICC-X 在现场调查和资料收集的基础上,完成了沣西车马坑保护方案,并于 2012 年 8 月至 2012 年 10 月对沣西车马坑实施现场保护一期工作,保护工作内容主要包括以下三个方面:车马 坑遗址的除尘和虫害治理;青铜器文物的清洗、除锈、修复、缓蚀、封护等处理;骨角质文物的清洗和加固处理。第 二期保护工作将根据车马坑遗址的检测结果对土遗址变化的因素以及虫害情况进行分析,提出治理方案。

### Collecting and sorting Silk Roads documentation 搜集、整理丝绸之路相关资料

 Proceed to collect, compile and translate international documentations of cultural heritage protection and conservation

With the published "Selected Works of International Documentation on Cultural Heritage Protection and Conservation" in 2007, IICC-X will proceed to collect, classify, organize and translate the literatures of international heritage protection and conservation regulations, charters, declarations, cases and programmes, provide sharing platform in multiple methods for the retrieval and inquiries from domestic and international institutes, specialists and organizations. Currently, further collection and translation work of relevant international documentations published in recent years are being implemented by IICC-X.

#### ● 继续收集编译国际文化遗产保护文件

在 2007 年出版的《国际文化遗产保护文件选编》基础上,继续收集、归类、整理和翻译丝绸之路 申遗各国相关的文化遗产保护法规、国际宪章及宣言、保护案例以及保护规划等各类文献,并通过多种 手段提供共享平台,方便国内外研究机构及专家、组织等进行检索查询。目前已进一步收集近年来发布 的国际文化遗产保护相关文件,展开翻译工作。

• Concentrate on the Silk Roads Nomination; build the "Silk Roads Library"

The objective of the "Silk Roads Library" is to provide retrieval and exchange platforms of bibliography and information for the Silk Roads study, oriented to the requirements of relevant international organizations, universities and colleges, research institutions, public, cultural heritage conservation and monitoring facilitators. All materials in the library are sorted into seven types, include article, book and conference, etc.; seventeen classifications, such as religion, military, economy, social science and culture, etc. A variety of collected paper-based documents have been organized and archived by different types and classifications, with on-line retrieval and reading services; eighty-six literatures have been digitalized and uploaded to the Silk Roads Library, functions of bilingual retrieval and inquiry have been launched for domestic and international academic studies of the Silk Roads. Data collection, shelving, translation and inputting are in progress.

### ● 围绕丝绸之路申遗工作着重建立"丝绸之路图书馆"

丝绸之路图书馆的目标是面向丝绸之路申报世界遗产相关的国际组织、大专院校、研究机构,文化 遗产保护、管理与监测机构以及一般公众提供丝绸之路研究书目检索与信息交流平台。丝绸之路图书馆 分为文章、书籍、会议等7个文件类型,宗教信仰、社会科学、军事、经济、文化等17个文件分类。目 前已按照文件类型,整理并归档了收集到的各类纸质资料,提供在线书目检索及借阅服务,另已有 86 本 文献完成了数字化,上传至在线的丝绸之路图书馆,以提供国内外丝路相关研究资料的中英文检索和查询, 资料搜集、整理、翻译和录入工作正在进行中。
